**POWER OF THE TRUST :**

1. The Trust may take any suitable step action as per the provisions contained in this instrument of Trust in order to achieve its objectives.
2. The trust has the power to establish manage run the institutions imparting knowledge, in the fields pre-primary, primary higher primary secondary and higher levels of education, engineering, medical, profession research etc.

4. Establish Hospitals, Labs, Libraries, Hostels and to provide facilities of accommodation to the staff and students of the above institution.
5. The Trust shall also have power to receive grants, funds, assistance of any kind from the state, centre or any board, council, commissions or any statutory body in order to achieve its purpose.
6. To raise secured or unsecured loans from the Nationalized Banks, Scheduled Bank, Co-Operative Societies, financial institutions, firms, companies or individuals with or without interest for the necessities of the trust to carry out the objects of the trust.
7. To obtain any movable or immovable property in the name of the trust either by purchase, gift, exchange, lease, hire or by taking over from other trust or societies or educational institutions or otherwise.

8. To mortgage, lease, pledge or create charge or sell or otherwise dispose of any of the properties of the trust for the necessities of the trust.

12. The Trust has the power to extend or receive co-operation or co-ordination from any other similar institution to achieve its own purpose or objectives.
13. The invest the funds of the trust in the modes specified under the provisions of Sections 10(23c),(iiiab),(iiad) & (vi) of the Income Tax Act & to vary the investments subjects to the provisions of the Income Tax Act.
14. To enter into contracts and agreements with persons, companies, firms, societies, or associations for purposes of putting constructions or for acquiring any movable or immovable properties in the name of the trust.
15. To do all such lawful acts, deeds and things that may be required to carry out the objects of the trust for proper realization and protection of benefit of the trust property.

**TERMS OF THE TRUSTEES :-**

1. The founder Trustee : They are the trustees throughout their life. After the death their respective sons can become trustee in place of deceased founder Trustee.
2. The Founder Trustees may nominate two more trustees, the terms and rights and privileges of such trustees will be determined by the founder trustees as per the needs and requirements of the trust.
3. The founder Trustee can nominate their successors to purportrate the objectives of the trust.
4. The vacancy in the Trusteeship may occur an account of resignation removal or deaths of a trustee. The remaining trustees will co-operate the new trustees in place of the vacancies so causes.
5. The President and Secretary shall have all powers to negotiate transact or come to a settlement or enter into any agreement with any firm or individual/s or State / Central Govt. Bank or Corporation / Municipality or any statutory body for and on behalf of the trust in the best interest of the trust.
6. The President and Secretary shall have the powers to appoint the staff, teaching, non-teaching, technical and general permanent or temporary and to punish suspend, discharge or dismiss them for Service in the Institutions under the Management of the Trust.

#### **BOARD OF TRUSTEES :**
